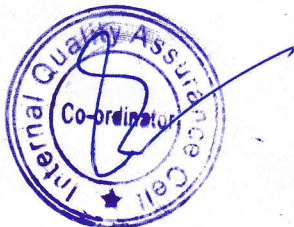

OBJECTIVES OF LEGAL SERVICES CAMP:

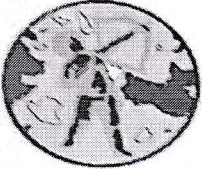
The Legal Services camp must aim to achieve the following objectives: -

1. TITLE OF ACTIVITY – Legal Aid Camp

2. PURPOSE AND OBJECTIVES- Legal Aid Clinics basically serve the purpose of providing legal advice not for the aim of earning profit but in General Public Interest. In law schools, though knowledge of law is thoroughly imparted. However theoretical knowledge is not sufficient when its applicability is not known. Opportunities for mootings are also limited. Students pursuing law have zeal and enthusiasm to provide legal services. Legal aid clinics thus serve the two-fold purpose, the first that they provide free legal services to economically weaker people and second, they direct the energies of the students of law in contributing to the society. These students are headed by their teachers. The members of the Legal Aid clinic are engaged in spreading legal awareness in rural areas through street plays as well as legal aid camps where they make the target population aware of different legal service programs and guide them to avail these facilities.

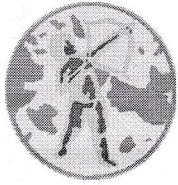
IPEM law Academy organized a Legal Aid & Awareness Camp on 31st October, 2021 (Sunday) under Unnat Bharat Abhiyan at Sadullapur Village, Ghaziabad. During the first half of the day the students of LL. B and B.A. LL.B. along with two advocates and 3 Faculty members provided legal awareness to the villagers, distributed pamphlets, in the second half, advocates met some of the villagers who came forward with their problems and gave legal advice to them. All guidelines of the government regarding covid -19 as social distancing and less gathering were followed by our entire team.
