Quality Initiatives taken during the Year 2021-22:-

- IPEM Law Academy conducted 2nd Dr. B.S. Goel Memorial Virtual National Moot Court Competition on 28.08.2021 & 29.08.2021. 19 teams including 57 participants pan India participated in the competition. Finals were contested between Teams from VM Salgaocar, College of Law, Miramar Goa and Delhi Metropolitan Education. It was judged by Col. Dr. A.K. Vashishta and Adv.
