भारत के माननीय सर्वोच्च न्यायालय के सिविल अपील संख्या 887/2009 दिनांक 08.05.2009 के निर्णय के अनुसरण में, विश्वविद्यालय अनुदान आयोग ने "उच्चतर शिक्षण संस्थानों में रैंगिंग के खतरे को रोकने के लिए विनियम, 2009" अधिसूचित किया है, जो देश के सभी उच्चतर शिक्षण संस्थानों पर अनिवार्य रूप से लागू है। ये विनियम विश्वविद्यालय अनुदान आयोग की वेबसाइट www.ugc.ac.in पर उपलब्ध हैं।

रैंगिंग मुक्त परिसर सुनिश्चित करने के लिए कुछ सिफारिशें और कार्रवाई योग्य बिन्दु, जिन्हें आपके विश्वविद्यालय तथा संबद्ध/सहयुक्त सभी संस्थानों में लागू करने की आवश्यकता है, निम्नवत् हैं:-

क) बुनियादी उपाय:-

1. रैंगिंग रोधी समिति तथा रैंगिंग रोधी दस्ते का गठन एवं रैंगिंग रोधी प्रकोष्ठ की स्थापना कर विभिन्न मीडिया के माध्यमों से इन उपायों का पर्याप्त प्रचार किया जाए।
2. संस्था की विवरणिका एवं सूचना पुस्तिकाओं में रैंगिंग रोधी चेतावनी का उल्लेख सुनिश्चित किया जाए।
3. विद्यार्थियों के सूचनार्थ और मार्गदर्शन के लिए प्रकाशित नामांकन-विवरणिकाओं, सूचना-पुस्तिकाओं, पत्रकों इत्यादि के कागजी प्रति के बजाय उनकी सॉफ्ट प्रतियाँ प्रकाशित की जाए तथा उनमें रैंगिंग रोधी निर्देशों के साथ-साथ इस संबंध में समुचित मार्गदर्शन को भी समाहित किए जाएँ।
4. रैंगिंग रोधी समिति तथा इसके नोडल अधिकारियों के पूरे पते और उनके संपर्क विवरण के साथ संस्थानों की वेबसाइटों को अद्यतन किया जाए।
5. विश्वविद्यालय अनुदान आयोग के विनियमों और इसके दूसरे संशोधन के अनुपालन में, प्रत्येक शैक्षणिक वर्ष में प्रत्येक विद्यार्थी और उनके माता-पिता द्वारा एक ऑनलाइन संकल्प पत्र जमा कराया जाए।
6. विश्वविद्यालय अनुदान आयोग ने 29 जून, 2016 को विश्वविद्यालय अनुदान आयोग के विनियमों में तीसरा संशोधन अधिसूचित किया है, जिसमें निम्नलिखित को शामिल करके रैंगिंग की परिभाषा का विस्तार किया गया है:-
"3. (i) रंग, प्रजाति, धर्म, जाति, नृजातीयता, लिंग (ट्रांसजेंडर सहित), सेक्सुअल ओरिएंटेशन, भेष, राष्ट्रीयता, क्षेत्रीय मूल, भाषाई पहचान, जन्म स्थान, निवास स्थान या आर्थिक पृष्ठभूमि के आधार पर किसी छात्र (नए या अन्यथा) पर लक्षित या शारीरिक या मानसिक शोषण (दादागिरी और बहिष्करण सहित) का कोई भी कृत्य।"
7. महत्वपूर्ण स्थानों पर सी.सी.टी.वी कैमरे लगाना।

ख) परामर्श तथा निगरानी के उपाय:-

1. विद्यार्थियों के साथ नियमित बातचीत और परामर्श से रैंगिंग के शुरुआती लक्षणों का पता लगाया जा सकता है और परेशानी करने वाले कारकों की पहचान की जा सकती है।
2. छात्रावासों, विद्यार्थियों के आवास, कैंटीन, विश्राम-सह-मनोरंजन कक्षों, शौचालयों, बस-स्टैंड इत्यादि का औचक निरीक्षण और कोई भी अन्य उपाय जो रैंगिंग को रोकने/ लगाम लगाने और अनुचित व्यवहार/घटना को रोकने में प्रभावी हैं किए जाएँ।
