Segregation of Waste

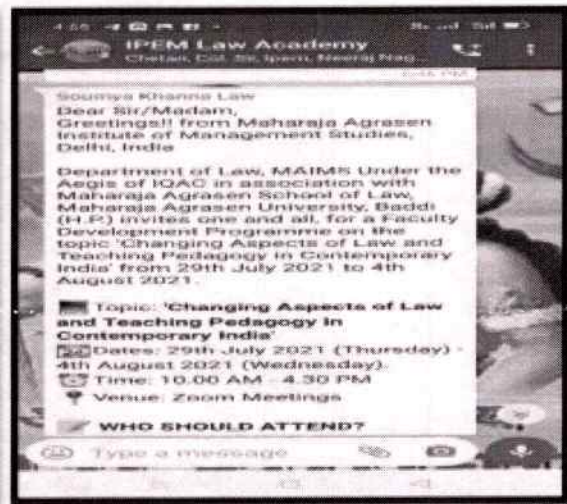
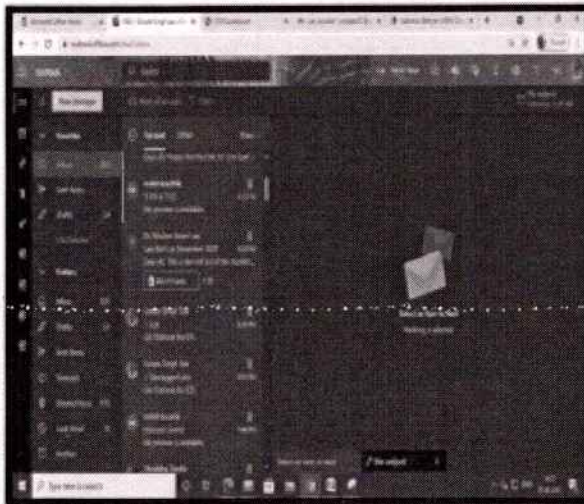


Modes of Digitalization (paperless concept)

- The Academy has Rain Water Harvesting System through Parle Agro.

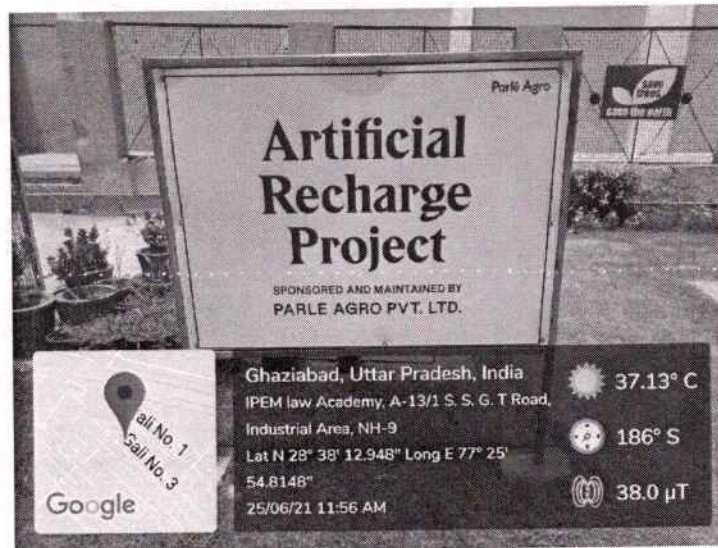
The Academy has proper drainage system for disposing off the water wastage.
