## **Report of Visit to National Lok Adalat at Patiala House Court, Delhi on 14.9.2019**

NALSA along with other Legal Services Institutions conducts Lok Adalats. Lok Adalat is one of the alternative dispute redressal mechanisms, it is a forum where disputes/cases pending in the court of law or at pre-litigation stage are settled/ compromised amicably. Lok Adalats have been given statutory status under the Legal Services Authorities Act, 1987. Under the said Act, the award (decision) made by the Lok Adalats is deemed to be a decree of a civil court and is final and binding on all parties and no appeal against such an award lies before any court of law. If the parties are not satisfied with the award of the Lok Adalat though there is no provision for an appeal against such an award, but they are free to initiate litigation by approaching the court of appropriate jurisdiction by filing a case by following the required procedure, in exercise of their right to litigate.

There is no court fee payable when a matter is filed in a Lok Adalat. If a matter pending in the court of law is referred to the Lok Adalat and is settled subsequently, the court fee originally paid in the court on the complaints/petition is also refunded back to the parties. The persons deciding the cases in the Lok Adalats are called the Members of the Lok Adalats, they have the role of statutory conciliators only and do not have any judicial role; therefore they can only persuade the parties to come to a conclusion for settling the dispute outside the court in the Lok Adalat and shall not pressurize or coerce any of the parties to compromise or settle cases or matters either directly or indirectly. The Lok Adalat shall not decide the matter so referred at its own instance, instead the same would be decided on the basis of the compromise or settlement between the parties. The members shall assist the parties in an independent and impartial manner in their attempt to reach amicable settlement of their dispute.

Keeping in view the above-said objectives IPem Law Academy has organized visit to Patiala House Court, Delhi on 14.9.2019 to witness the proceedings related to settlement of cases under Motor Accident Claim Tribunal, Challan under Motor Vehicle Act in National Lok Adalat organized by Delhi Legal Service Authority. Students of LL.B (1 semester) & B. A. LLB (5 semester) has observed how settlement proceeding is going on. The Judge is doing the role of mediator and tried to compromise the matter. Around 50 students were present there. The visit was coordinated by Sudhakaran & Archana Singh under the supervision and guidance by Prof





4. To spread awareness about the various repercussions those are faced by people and the ways to achieve justice.

### SPEAKERS:

The meeting was first addressed by Dr. Meenakshi Tomar who introduced all the IPEM members to the villagers and felicitated our Guest Mr. Anand Chaudhary and Mr. Amit Pant Parshad of the area then proceeded with the rights of the people and women. After that Mr. Sudhakaran addressed the assembly and told the villagers that our IPEM team works on the rights of the women and needy by providing legal aid and assistance to the poor. He continued by speaking of the various ways of repercussions faced by women. Women sexually exploited by



being publicly undressed, Verbally abused in the public. He mentioned some of their rights. And after him our student Mr. Hari Singh, Mr. Shatrughan spoke about dowry death and domestic violence respectively.

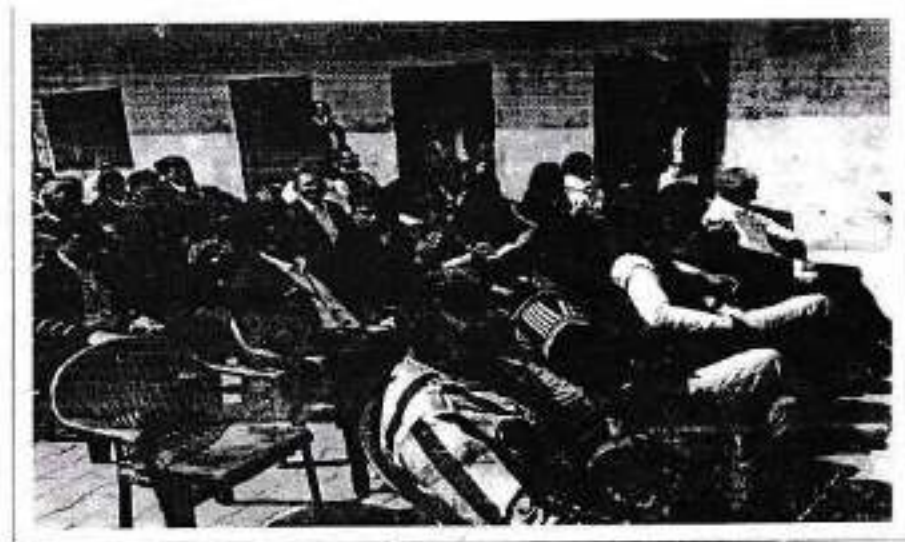

## Report of National Lok Adalat at District Court, Noida

Date: 23rd Apr, 2018

Date : 22<sup>nd</sup> April, 2018

Timings : 10.30. A.M. Onwards

Venue : District Court, Noida.

In recent times, the need for Alternate Dispute Resolution System, like the Arbitration, Mediation, Conciliation etc has taken up unprecedented significance, especially in light of the huge number of litigations pending in the Indian Courts. The Institution of Lok Adalats have come to the fore as one of such devices which not only help save time of the litigants but is also cost effective and reduces the workload of already burdened Courts. Students not only need the conceptual knowledge about the Law subjects but also practical exposure in this field.

Towards this end, the IPEM Law Academy organized a visit to The National Lok Adalat held at the District Court Noida on 22<sup>nd</sup> April 2018 at 10.30 AM, for LL.B VI & B.A.LL.B. X Sem students. About 35 Students had attended this National Lok Adalat and witnessed the proceedings taking place there.

The Activity Coordinators had briefed the Students about the Background of the Lok Adalats and its constitution & functioning under the Legal Services Authorities Act. Further they were also apprised that once a decision is reached between the Parties in the Lok Adalat, it is final and binding and cannot be challenged. In the event, that the parties fail to arrive at a compromise, the case is taken up in the usual manner in court and thereafter, decided on merit. The Coordinators had thereafter, asked the students to form groups of 6-7 and were then advised to approach the various benches of Judges who were disposing of the matters in the Lok Adalat to observe the proceedings. They were asked to note down their brief facts and the terms of Compromise, if any reached therein. They were also asked to interview the Litigants to get first hand information. The students were directed to politely inquire from the parties directly about their cases or matters being disposed of. The students were however cautioned to act discreetly and with sensitiveness when collecting information in matrimonial matters or Motor Accident Claims.

They were also briefed about the types of the cases that can be dealt with at the Lok Adalat. They cover, civil matters, criminal cases of petty nature and, such matters which are disposed of with imposition of fines.

### Types of Cases disposed of in the National Lok Adalat & witnessed by the students

#### 1. Matrimonial Dispute Cases:

The students were able to witness matrimonial matters pertaining to the claim of Maintenance by the wife and decree of Divorce in the Family Court. The Presiding officer



was seen directly interacting with the aggrieved wife, sidelining the Advocate to ensure that no undue influence has been exercised upon her.

## 2. Bank Loan Recovery Matters

These matters formed the majority of the cases being decided there. Representatives of Several banks (Syndicate bank, SBI, Bank of Patiala, Punjab National Bank etc) were also present in bank Loan recovery cases put up for disposal there. Most of the parties had the grievance of how the claimed amount far exceeded the principal amount due to high rate of interest. In one of the matters the Bank had not issued a NOC to the borrower party despite the payment having been made under the order of Lok Adalat.

## 3. Motor Accident Claim Matters

Several matters pertaining to the claims made in Accidents under the Motors Vehicle Act were also observed by the students at the Lok Adalat. In few cases it was seen that despite issuance of several summons by the Tribunal, the Insurance Companies had failed to make an appearance in these cases. In two cases of fatalities, the legal heirs/representatives (Wife & Mother of the deceased victim) were prosecuting the matter. Such delicate matters were asked by the students to be dealt with sensitively while gathering information.

## 4. Miscellaneous Matters

Apart from the above mentioned cases, other matters such as Drinking/Consuming Alcohol in the Public Place & creating Nuisance, Gambling, seeking Compensation in acquisition of land at Hapur at revised rate From NHAI, Illegal sale of the Land in contravention of the High Court Order/Notification, Succession Claims by legal Heirs of the deceased, Challan in Violation of Traffic Rules, were also put up in the cause list for disposal at the Lok Adalat.

The students had visited the District Judge Court, Additional District Judges Court, Civil Judge Senior & Junior Division Court, Family Court, Chief Judicial Magistrate Court, Additional Chief Judicial Magistrate Courts to get the hands on experience.

### Address By Ms. Neelu Mainwal ADJ (Senior Devision)

Upon the final leg of the visit, the Activity Coordinators were also able to request ADJ, Smt. Neelu Mainwal to address our students, which he graciously agreed to. She gave a brief account of the origin of Lok Adalat as provided under the Legal Service Authority Act and the various provisions under the Civil Procedure Code & Criminal Procedure Code where the parties could settle their cases through the Lok Adalat. She further, elaborated the cases which could be made subject matter of the Lok Adalat, viz. civil matter, cases of compoundable nature, petty matters, summary trial cases. She had further elaborated upon the types of cases that he had dealt with in the Lok Adalat, viz. Theft of Electricity, Non-Payment of Electricity bills, objections to the Final Report submitted by the Investigating officers, Motor Accident Claims, etc. She had also satisfactorily entertained the queries of the Students regarding other cases also.



Thereafter, the students had taken a break for refreshment at the Court canteen. The Faculty members had profusely thanked ADJ Ms. Neelu Mainwal in securing the permission from DLSA, Noida, for our students to attend the Lok Adalat and coordinating the visit. The students had been asked to prepare a Report upon this National Lok Adalat to be recorded in their Project File. The students had had an educative and an informative visit.

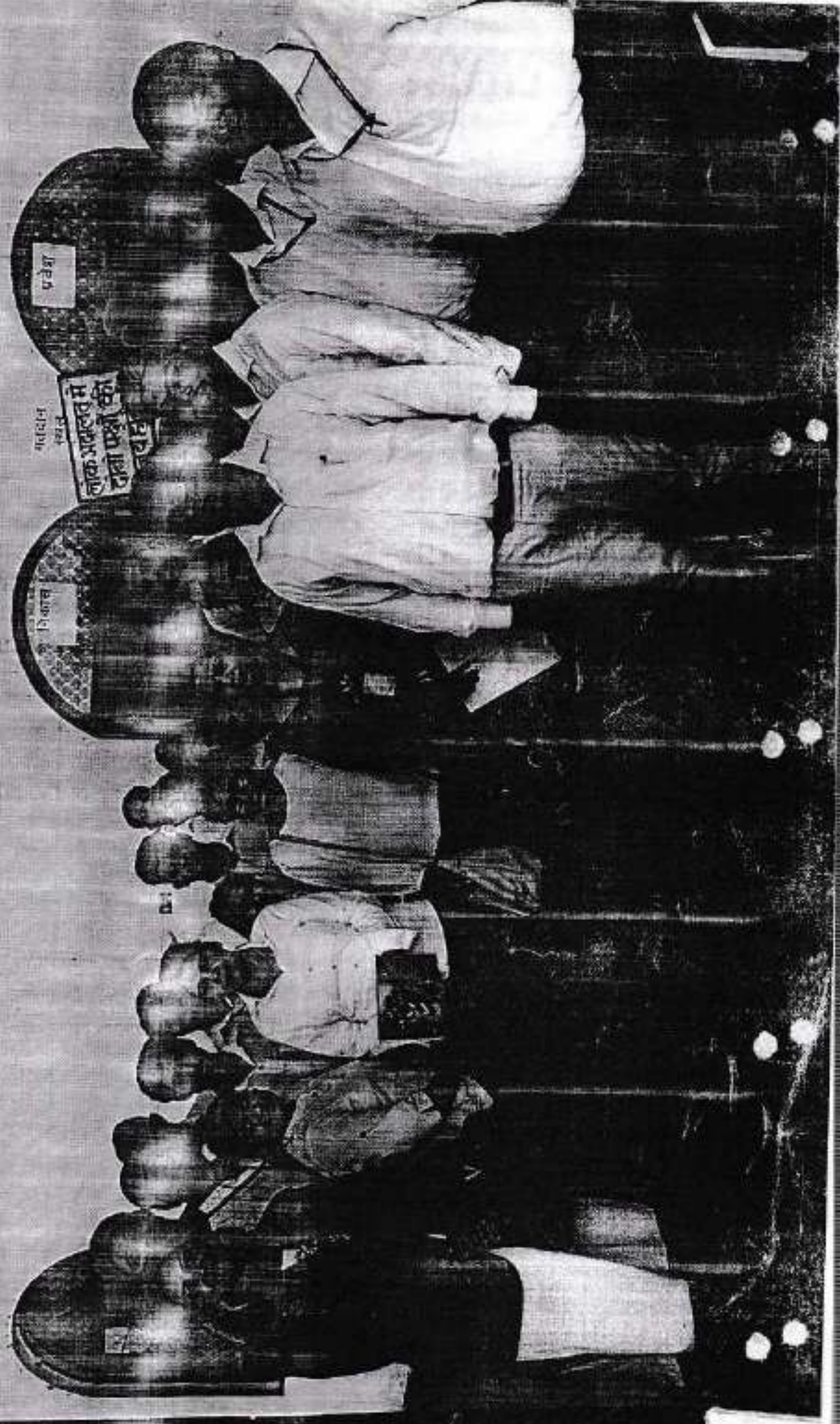

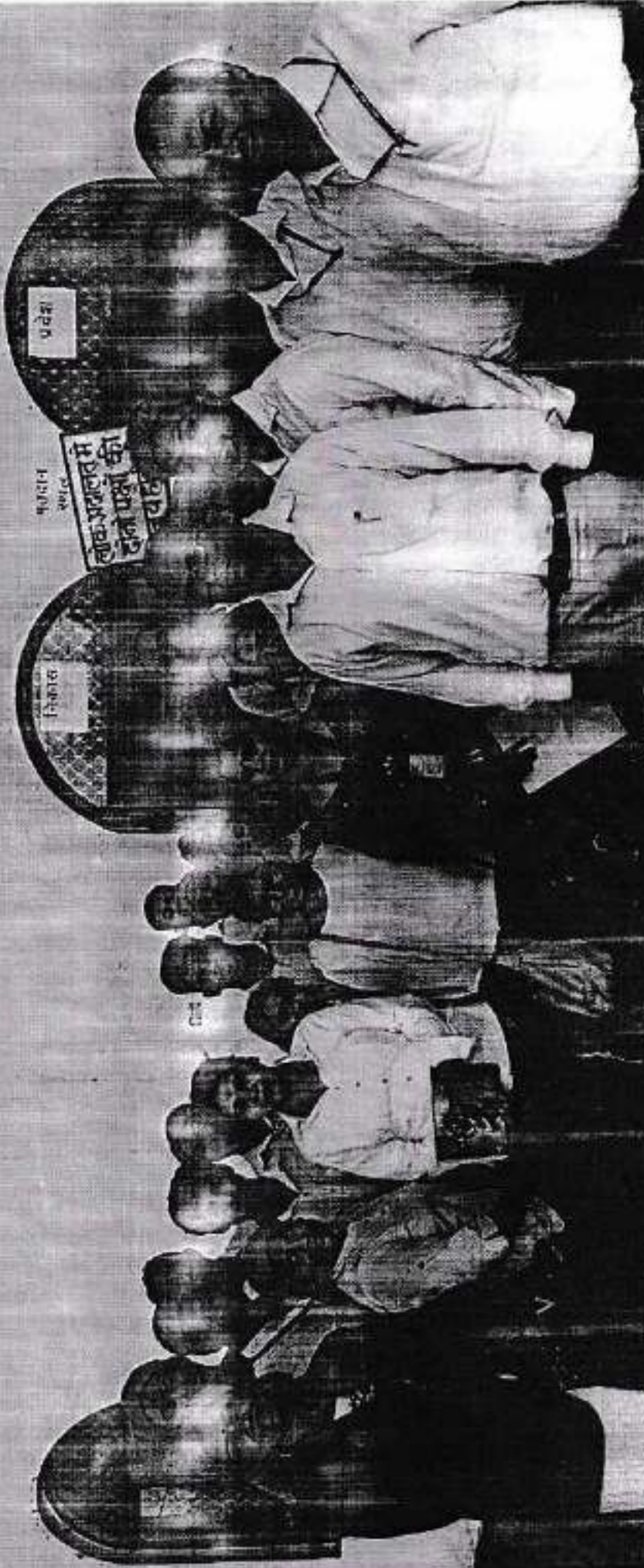

## Report of Display Poster Competition on theme of Earth Day on 24.4.2018

The idea for a national day to focus on the environment came to Earth Day founder Gaylord Nelson, then a U.S. Senator from Wisconsin, after witnessing the ravages of the 1969 massive oil spill in Santa Barbara, California. Inspired by the student anti-war movement, he realized that if he could infuse that energy with an emerging public consciousness about air and water pollution, it would force environmental protection onto the national political agenda. Senator Nelson announced the idea for a "national teach-in on the environment" to the national media; persuaded Pete McCloskey, a conservation-minded Republican Congressman, to serve as his co-chair; and recruited Denis Hayes from Harvard as national coordinator. Hayes built a national staff of 85 to promote events across the land. April 22, falling between Spring Break and Final Exams, was selected as the date.

On April 22, 1970, 20 million Americans took to the streets, parks, and auditoriums to demonstrate for a healthy, sustainable environment in massive coast-to-coast rallies. Thousands of colleges and universities organized protests against the deterioration of the environment. Groups that had been fighting against oil spills, polluting factories and power plants, raw sewage, toxic dumps, pesticides, freeways, the loss of wilderness, and the extinction of wildlife suddenly realized they shared common values.

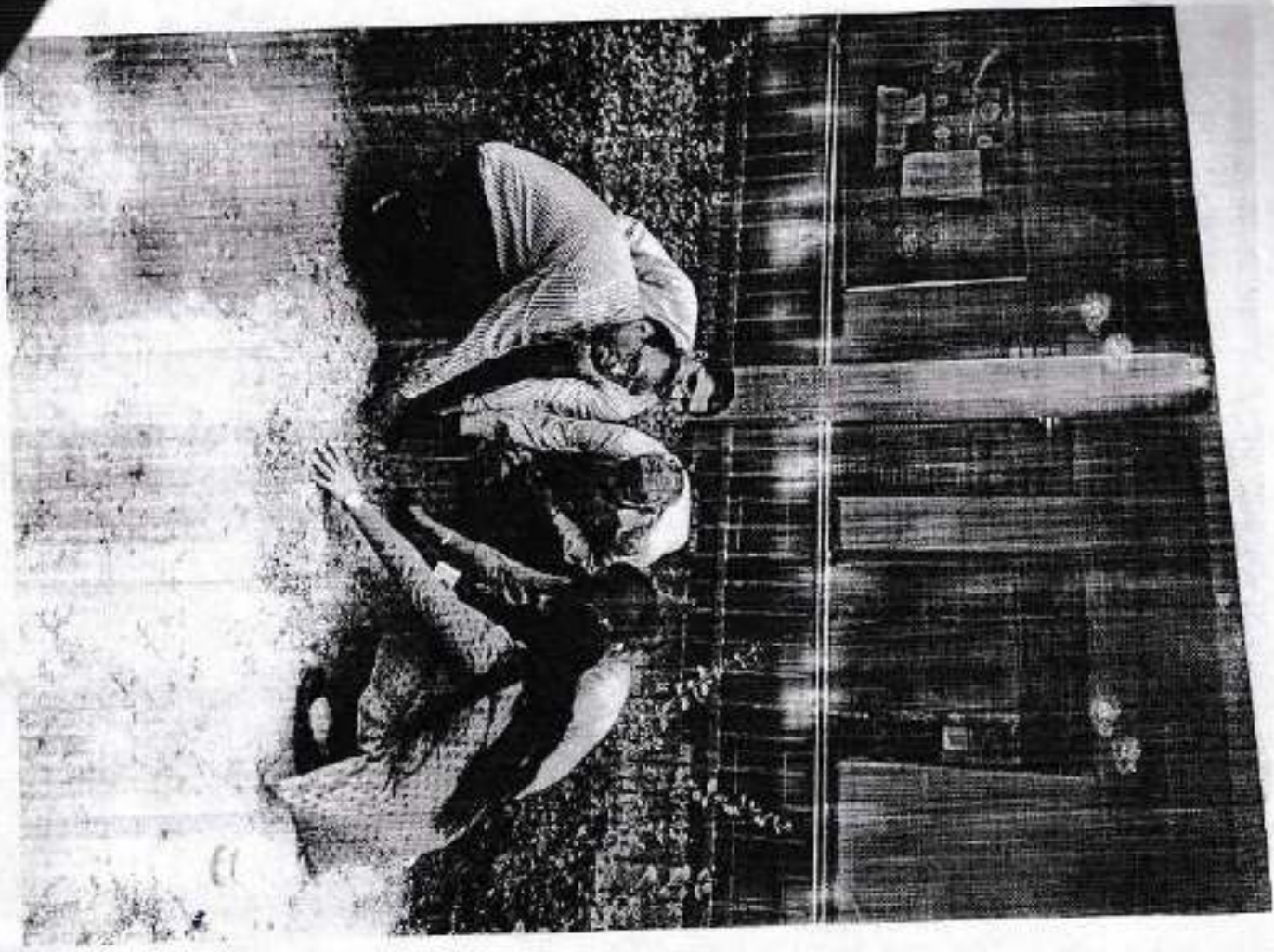

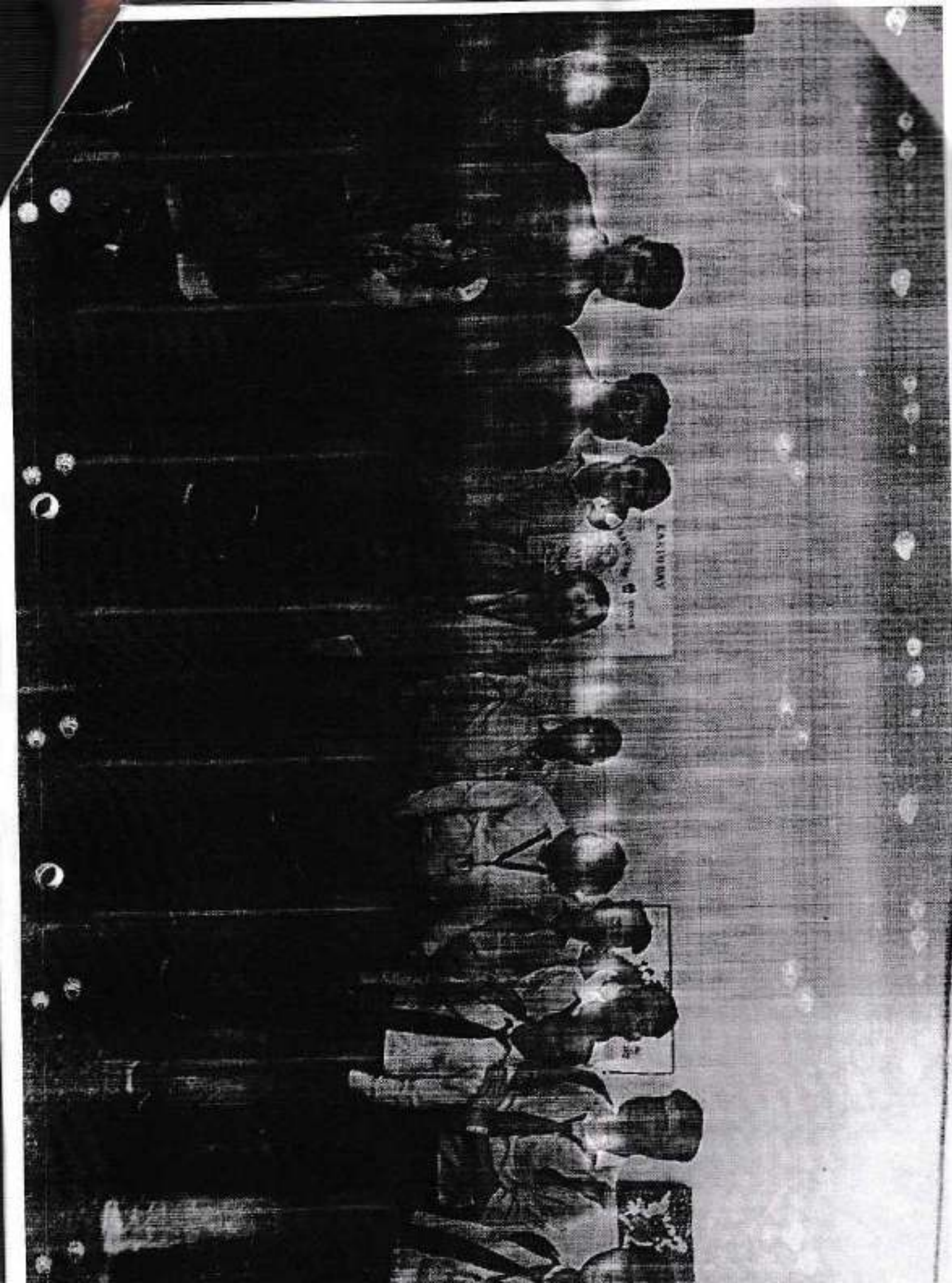

It has a seating capacity of 160 and usually a pass is issued only for one hours, that is specified in the pass i.e. 5-6 P.M. Lok Sabha visiting time. There was a strict rule regarding entry. We were not allowed to carry any things; i.e. No Phones, No Pen & Papers, Cameras, coins, nothings. Only one I.D and Money in notes form is allowed. Every stage there is strict security officer, who instruct time to time. Even we have to sit straight. For students parliament proceedings are very important. It is the most important part of any democracy. It is the place where law has been legislate and the law which the students read in their courses.

### **Experience of visiting:**

It was fascinating for us to see all the proceedings live which we normally see on T.V. The elected members followed the formal protocol. They address the chair of the House and they speak to each other through him or her. Another fascinating feature is the headphones where anyone can switch the language in which want to hear the proceeding. Even some live interpretator is also there. The large & broad corridor running around the building. Large Image of Mahatma Gandhi in Lawn is surely to catch the attention. Apart from Pt. Nehru, Sardar Patel, Mr. Ambedkar's Statute were also there.

## Report of Legal Aid Camp on 18.8.2018

Because I believe that each of us – no matter what our age or background or walk of life – each of us has something to contribute to the life of this nation.*—**Michelle Obama**

Legal Aid Clinics basically serve the purpose of providing legal advice not for the aim of earning profit but in General Public Interest. In law schools, though knowledge of law is thoroughly imparted. However theoretical knowledge is not sufficient when its applicability is not known. Opportunities for mootings are also limited. Students pursuing law have zeal and enthusiasm to provide legal services. Legal aid clinics thus serve the two-fold purpose, the first that they provide free legal services to economically weaker people and second, they direct the energies of the students of law in contributing to the society. These students are headed by their teachers. The members of the Legal Aid clinic are engaged in spreading legal awareness in rural areas through street plays as well as legal aid camps where they make the target population aware of different legal service programs and guide them to avail these facilities.

Article 14 of the Constitution of India talks about equality before law and Article 39A provides for equal justice and free legal aid.

“Article 39A of the Constitution of India provides for holistic approach in imparting justice to the litigating parties. It not only includes providing free legal aid via appointment of counsel for the litigants, but also includes ensuring that justice is not denied to litigating parties due to financial difficulties.”

“The State, which has been mandated by Article 39A of the Constitution to ensure that the operation of the legal system promotes justice by providing free legal aid and that opportunities





for securing justice are not denied to any citizen by reason of economic or other disabilities, has not been able to create an effective mechanism for making justice accessible to the poor, downtrodden and disadvantaged. In last two and a half decades the institution of the legal services authorities has rendered yeoman's service in the field of providing legal aid to the poor but a lot is required to be done for ensuring justice to economically deprived section of the society and those who suffer from other disabilities like illiteracy and ignorance

Keeping in view of the above stated objectives IPEM Law Academy has organized **Legal Aid Camp**, Domestic Violence against Women at Sector -4 Raj Nagar, Ghaziabad on **18<sup>th</sup> August, 2018**. Faculty and students have participated in the legal aid camp by expressing their thoughts and views on the above-stated issues. The Camp was started with tribute to Late Atal Bihari Vajpayee (Former Prime Minister) by Ms. Sheela along with Faculty Members and Students for Five Minutes. The Introduction and importance of Legal Aid Camp was done by Dr. Meenakshi Tomar (Assistant Professor) which help to solve the problems of weaker sections of the society which are helpless in getting justice from the Courts, followed by Mr. Sudhakaran (Asst. 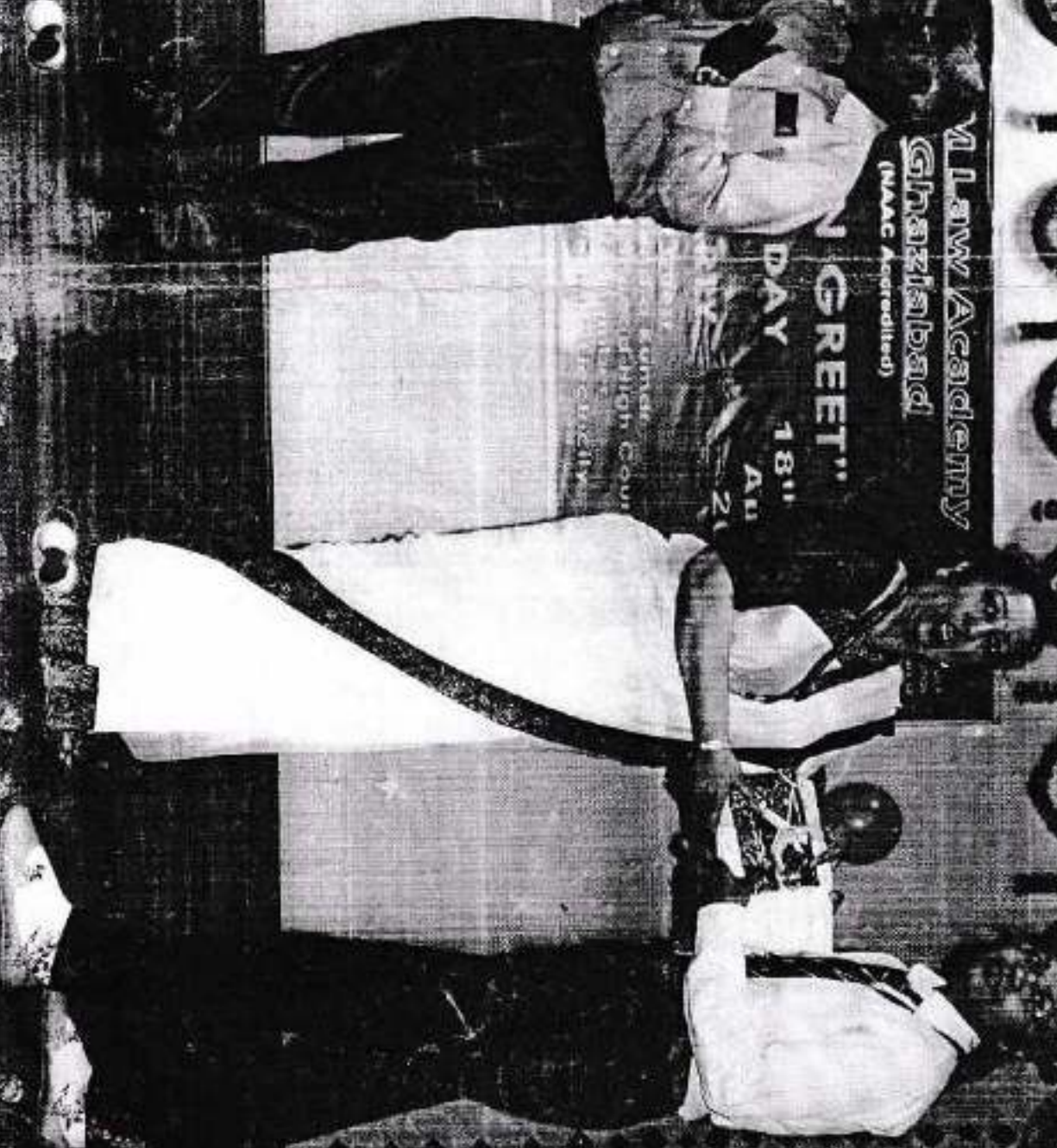
