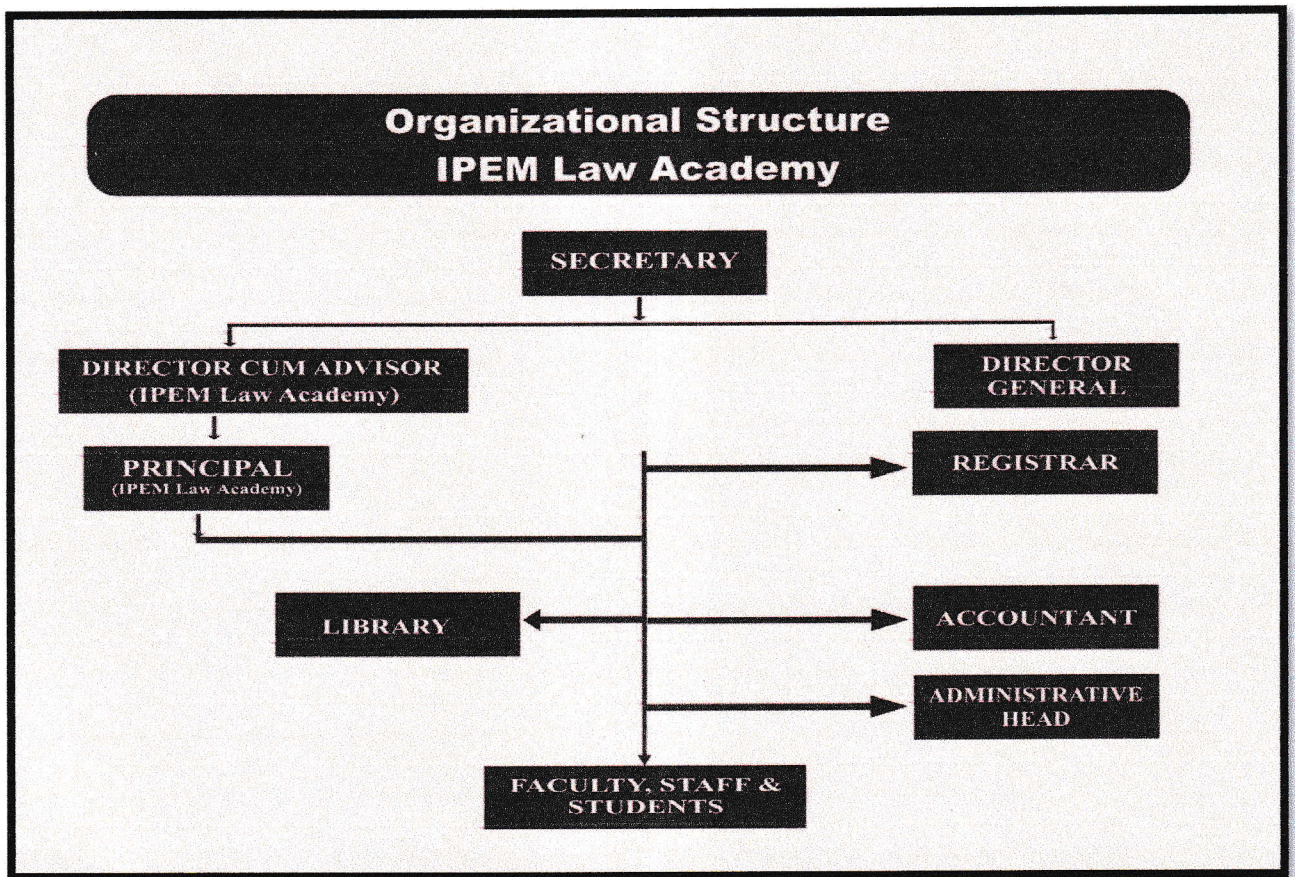

- All the faculty members are encouraged to participate & lead various academic & administrative roles to deliver high quality education to the students.

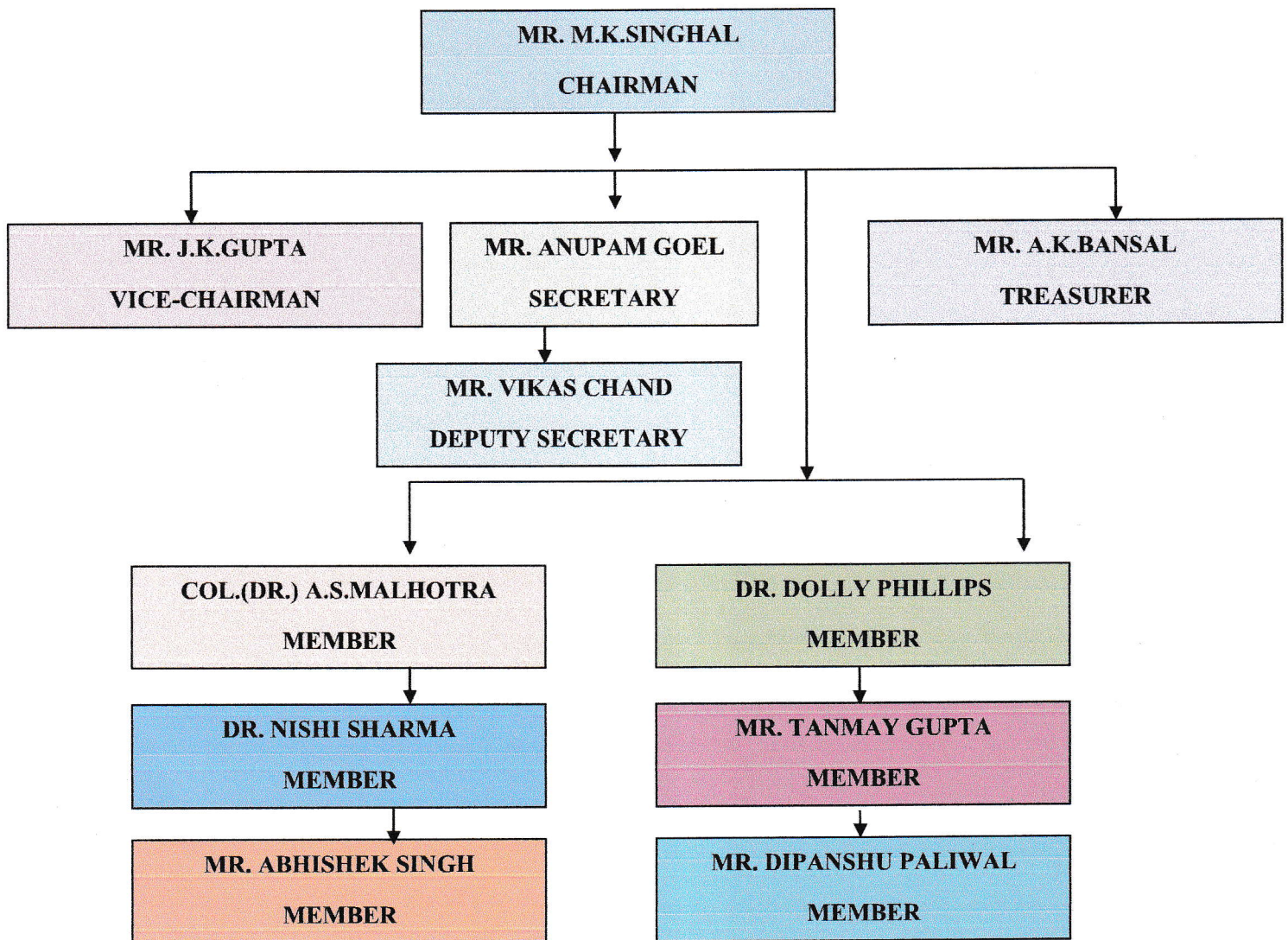

The objective of the **Internal Quality Assurance Cell** is to facilitate the integration of the various activities of the institution and institutionalize the best practices.

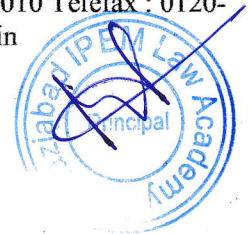
