WOMEN EMPOWERMENT : EMERGING TRENDS AND CHALLENGES

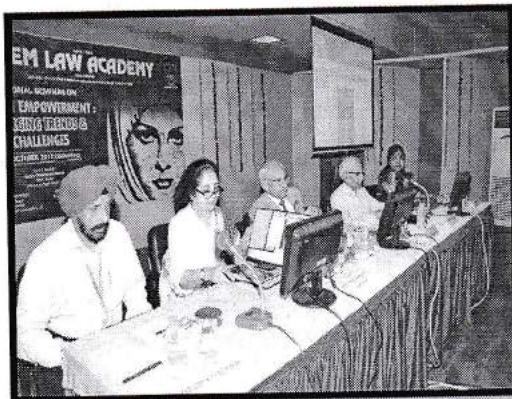
