## Moot Proposition

### IN THE SUPREME COURT OF UNION OF IDINA

1.) Union of Idina is a socialist, sovereign, secular, democratic and republic country with a legal regime and a governmental structure similar to that of India. Union of Idina has witnessed exponential growth in its technological sector and emerged as a pioneer in digitizing their entire ecosystem. The users of social media platforms, digital media platforms and OTT platforms are ever increasing in this digital environment. Its commendable adaptation of technology has grabbed the attention of the world's largest technology businesses.

2.) Handbook, one such multinational technology conglomerate has entered the Union of Idina market and has become the most popular social media platform among the inhabitants of Idina. Handbook allows the user to create and share the photos, stories, and videos with the friends and followers and is heavily relied on by the population of Union of Idina for their social media needs. However, to use Handbook one must provide their name, date of birth, phone number and email id.

3.) Philip Dutta, one of the leading comedian in the Union of Idina known for his observational comedy about absurdities of life. He is also the founder and host of the show 'Speak Up' which premieres on Handbook and jokes about politics and persistently critiques the government and its policies through satire in from of skits and standup comedy. Speak-up has seen a significant increase in their subscriber database and has led to Philip becoming a household name in the Union of Idina.

4.) The government organization that keeps track of Idina's crime data, the Organization for Monitoring Crime ("OMC"), releases its "Annual Report of 2023" in the month of November. It claims that because of the large increase in social media and digital media platform usage due to digitization of the nation, there has been a sharp increase in cyberbullying, trolling, the sharing of fake news, cyberstalking, and other cybercrimes. The OMC advised the government to act quickly to address the threat posed by these problems.

5.) After reading the OMC Annual Report in early 2023, the Union Government recommended the Ministry of Electronics and Information and Technology (MeIT) to develop better regulations governing all digital platforms to combat the rise of such cyber-crimes. The Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2023[1] (referred to as the "IT Rules") were published in the Official Gazette on December 20th, 2024. These regulations mandated the appointment of compliance officers and the establishment of self-regulatory bodies by the intermediaries and digital media platforms. In addition, the intermediaries will have to comply with the regulations' provisions and Section 69 of the Information Technology Act, 2000[2] ("IT Act, 2000") in order to reveal the content of any electronic message pertaining to the 'initial originator', the person responsible for the creation of such message.

- 6.) Three bomb explosions happened in a row on February 17, 2024, at approximately 5:55 p.m. in Lexia, the capital city of Union of Idina. 15 children and 45 adults perished in the series of explosions. Despite the passage of significant time, the police force's efforts to apprehend the offenders proved fruitless.
- 7.) On February 20th a doctored video of Philip Dutta started doing rounds on Handbook. In this video Philip could be seen praising the terrorist responsible for the bomb blasts, saying that such blasts and terrorist activities will become a commonplace in the Union of Idina as it was straying away from its socialist path by making laws that are uplifting the majority and suppressing the downtrodden even more and the suppressed people will rise through violence. The Idina Times (“TRT”) is one of the leading digital media platforms which is usually trusted for its ground reports backed with empirical data, saw this video and decided to share the said video on their Handbook page while condemning the actions of Mr. Philip. The video became viral and spread like wildfire. As the wounds of the blast were still fresh, the statements of Mr. Philip as seen in the doctored video were considered distasteful and ludicrous and ignited a wave of hatred towards him from the common people who had suffered due to such blasts, leading to protests against Mr. Philip.
- 8.) Mr. Philip, after seeing the uproar and realizing that a doctored video of him was circulating on the internet and then has been shared by The Idina Times on their handbook page, reached out to The Idina times but received no reply from their side. In response to the silence and non-removal of the video from their page by the Idina Times, Mr. Philip filed a suit for defamation in the High Court of Lexia asking for pecuniary awards, however, it was denied by the court on the basis that it was not the news agency’s original post, but rather it was sharing of someone else’s already posted video. Mr. Philip aggrieved by this judgement approached the Supreme Court of Idina under Article 136 of the Constitution of Idina.[1]
- 9.) Troubled by the spreading of hate against him, and lack of response from the Times of Idina he approached Handbook for the removal of the doctored video from their website and to stop the further spreading of the video, stating that the news video being fake, comes under the newly enacted IT rules and it’s the duty of Handbook to stop the spread of such information. Handbook, in response provided with the documentary evidence that that they have processed the complaints. They do not initiate any transmission through their website/app and neither decide who are to be the recipients of such transmissions. However, he received no reply from Handbook regarding the issue for the next few days while the video continued to spread and the situation continued to worsen.
- 10.) Aggrieved by their response Mr. Philip approached the High Court of Idina under Article 226, contending that his right to life had been stifled by the slow response of Handbook. He contended that Handbook had not followed the newly introduced IT rules and had not stopped the spread of false news. This has damaged his reputation and quality of life and had made him the recipient of death threats and harsh words wherever he visited. 13.) Taking note of the various cases filed by Mr. Philip, the Chief Justice of Supreme Court of Kronos tagged all the matters together and listed before a Constitution Bench. The Court formulated the following issues:

1. Whether the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021 be declared as unconstitutional on the basis of being violative of Right to Freedom of Speech?
2. Whether the reposting of alleged news by a news agency be considered as defamation?
3. Are the grounds for the interception, monitoring or decryption reasonable restrictions on the Right to Privacy provided under the Constitution of Idina?

Is the right to remain anonymous, a fundamental right provided under the constitution of Idina?

## **Note:**

This Moot Problem is purely intended for the Moot Court Competition and educational purpose amongst law students.

1. Only the laws of Union of Idina are parimateria to the laws of India and no such fact is parimateria to any country. This Moot Proposition is purely a work of fiction and resemblance to any such incidence shall be purely co-incidental.
2. The participants are required to prepare their submissions from each side of the case. They are not allowed to add a new issue, however, participants are free to club two issues or add sub-issues while addressing the issues mentioned.

## DEFINITIONS

1. “Competition” means the 5th Dr. B.S Goel National Moot Court Competition, 2024.
2. “Institution” means any recognized law school/college or university.
3. “Memorial” means the written arguments submitted, on behalf of both the Applicants and Respondents, according to the official Competition Rules by each Team. Memorials are also referred to as written pleadings.
4. “Organizing Committee” includes the members of the 5th Dr. B.S Goel National Moot Court Committee.
5. “Payment Receipt” means a written acknowledgment that the payment of the registration fees has been made.
6. “Applicant” means the party which is presenting an application to the court alleging the commission of a wrong.
7. “Researcher” means the team member whose role is confined to preparation of the Memorial and is not allowed to speak in the oral rounds.
8. “Respondent” means the party against whom the petition is filed.
9. “Rules” means these official Competition Rules and any applicable supplements to these Rules published by the Organizing Committee.
10. “Speaker” refers to the members of the team who will be pleading before the judges in the oral rounds.

## TEAM COMPOSITION AND ELIGIBILITY

1. Students pursuing the three or five year courses of the Law Program or its equivalent in the academic year 2023-2024 from any recognized law school/college/university in India/abroad are eligible to participate.
2. Any recognized law school/college/university shall be entitled to send only one (1) team to the Competition.
3. The participating team shall comprise a minimum of two and a maximum of three members. In a team of two members, both the members shall be designated as Speakers. In a team of three members, two members shall be designated as Speakers and the third member of the team shall be designated as a Researcher.
4. No additional member or team coach is allowed to accompany the team.

## LANGUAGE

The official language of the competition shall be English.

## REGISTRATION

The team must register themselves by filling up the Google Registration form at <https://forms.gle/4eLJb6anPHhKFKJ17> before 20th of June 2024

## REGISTRATION FEE

1. The Registration fee shall be Rs. 2500/- (Rupees Two Thousand and Five hundred only) for Participant Team and each participating team consist of 3 members (Two Speakers & one Researcher). No additional member shall be permitted.
2. Each team shall complete the registration within the stipulated time.
3. Fee once paid is non-refundable
4. The registration is a two-step process comprising of filling up of the registration form and payment of the registration fee as provided in Rule 7.
5. Registration will be open till 20th of June 2024, 11.59 P.M. IST.

## DRESS CODE

1. All Participants (Both Male and Female) shall wear Black Blazer, Black Trouser, White Shirt, Black Shoes with Black Socks and Black Tie.
2. Non-Compliance of Clause 1 will lead to penalty of marks.

## CLARIFICATIONS TO THE MOOT PROPOSITION

1. Participating teams may request for clarifications to the official moot problem by sending an email to [ipemmoot@ipemgzb.ac.in](mailto:ipemmoot@ipemgzb.ac.in) latest by 1st of July 2024.

## ANONYMITY

1. The participating team shall be allotted a team code upon final registration.
2. The student counsels shall not state their names or the names of the institution to which they belong during the oral rounds, and instead must use the code allotted.
3. The team shall not disclose their identity anywhere in their written Memorials and instead should use the code allotted.
4. Non-compliance with the Rules 2 and 3 shall result in immediate disqualification of the participant/team.
5. The decision of the Organizing Committee in this regard shall be final and binding.

## MEMORIAL

1. Each team shall prepare an Appellant and a Respondent Memorial.
2. One (1) soft copy (in PDF format) must be emailed to [ipemmoot@ipemgzb.ac.in](mailto:ipemmoot@ipemgzb.ac.in) and four hard copies to be sent at IPEM Law Academy (A-13/1, South Side G.T Road, Industrial Area, Ghaziabad, Uttar Pradesh 201010) latest by 15th of July 2024 (23:59 hours IST) with the subject "Memorials for Team Code". The file names of the copies of the Memorials must contain only the team code and the side being represented in the following format: e.g. (for Team Code 13) 13A or 13R, "A" being for "Appellant" Memorial and "R" for "Respondent" Memorial and so forth.

## 3.Format of Memorials

1.The Memorials shall necessarily consist of only and only the following sections:

- a) Cover Page
- b) Table of Contents
- c) List of Abbreviations
- d) Index of Authorities (with page number where the authority has been cited)
- e) Statement of Jurisdiction
- f) Statement of Facts (not exceeding 2 pages)
- g) Statement of Issues
- h) Summary of Arguments (not exceeding 2 pages)
- i) Arguments Advanced (not exceeding 20 pages)
- j) Prayer (not exceeding 1 page)

2. Each Memorial shall have the following and only the following contents on its cover page:

- a) The team code on the upper right-hand corner of the cover page
- b) The name and place of the forum
- c) The relevant legal provision under which it is filed
- d) Name of parties and their status
- e) On whose behalf the memorial is filed

3.The Memorial shall be made on A4 size paper, with the following mandatory formatting specifications:

- a) Font Type: Times New Roman
- b) Font Size:12
- c) 1.5 line Spacing
- d) Margins: 1 inch on each side.

For footnotes, the formatting specifications are:

- a) Font type: Times New Roman
- b) Font Size:10
- c) Single Line

4.The following colour scheme shall be followed for the Cover Page of the Memorial:

Appellant: Blue Respondent: **Red**

## EVALUATION OF MEMORIAL

1. Every Memorial will be marked on scale of 100.
2. The Memorial shall be evaluated according to the following criteria:
  - a) Knowledge of Law and Facts: 20 Marks
  - b) Proper and Articulate Analysis: 15 Marks
  - c) Depth and Use of Research: 15 Marks
  - d) Organisation, Presentation and Overall Formatting: 15 Marks
  - e) Grammar and Language: 10 Marks
  - f) Novelty of arguments: 15 Marks
  - g) Clarity of Thought and Originality: 10 Marks

## EXCHANGE OF MEMORIALS

There shall be an exchange of Memorials online/offline between the respective opposing teams, in accordance with the fixtures as determined by Committee, prior to all the rounds of the Competition.

## ORAL SUBMISSIONS

1. The oral pleading shall be conducted on Hybrid mode:
2. Any form of scouting during the completion is strictly prohibited and shall entail instant disqualification of the Team.
3. The order in which Teams shall submit their Oral Pleadings throughout the Competition shall be: Speaker 1 for Applicant, Speaker 2 for Applicant; Speaker 1 for Respondent, Speaker 2 for Respondent.
4. Before the start of the oral rounds, each Team shall inform the Court Officer regarding the order of speaking as well as allocation of time between themselves and the time reserved for Rebuttals.
5. If a Speaker speaks for more than the time reserved for him/her, the extra time used by such Speaker shall be deducted from the time allotted to the second Speaker of that team. If the second Speaker exceeds the time allotted to him/her, such time exceeded shall be deducted from the time reserved for Rebuttals.
6. Compendium can be submitted to the Court Officer prior to the oral rounds which will be submitted to the judges at their discretion. Any further material may be passed at the discretion of the Panel. Team members can pass research materials to the speaker in a discreet manner.
7. Any team which violates any of the Rules with respect to the oral rounds may be penalized. The decision of the panel shall be final in this regard.
8. All memorials received within time schedule will be evaluated by the Memorial Evaluation Committee (MEC) to be constituted by the IPEM Law Academy, Ghaziabad.

## STRUCTURE OF THE ORAL ROUNDS

1. The Competition shall consist of four sets of rounds: The Preliminary Rounds, the Quarter Final Rounds, the Semi Final Rounds, and the Final Round.
2. Preliminary Round
  - Each oral round will be for a period of 30 minutes, (including Rebuttals), wherein each Team will be allowed 15 minutes. Any extension of time beyond this specified period is subject to the discretion of the Panel.
  - In case of any Team fails to appear in an oral round, the round shall be conducted ex-parte and the scoring shall be done as if the defaulter team had been present and arguing.
  - No Team shall reserve more than 5 minutes for Rebuttals. The winner of each court-room will be decided on the basis of the scores awarded by the judges in this round and the marks awarded by MEC IPEM formed by the Moot Court Society.
  - At the end of preliminary rounds, the top eight teams will qualify for the quarter finals on the basis of their wins. In case of a tie, the marks of the memorials will be considered in addition to the scores of preliminary rounds. The team with the higher score will advance to the Quarter Finals.
3. Quarter-Final Round On the basis of combined score of memorials as well as oral pleadings top eight teams will qualify for quarter- final. Quarter-final round would be conducted on MS-Teams on hybrid platform. Quarter-final round of competition will consist of 40 minutes for oral pleadings. Applicant and Respondent are each allotted 20 minutes. Each mooter shall speak for a minimum of 5 minutes. A maximum of 5 minutes is to be allotted for rebuttal round. This round will be knock-out round and four teams will qualify for semi-final round.
4. Semi-Final Round Semi-final round would be conducted on MS-Teams via hybrid platform. The semi-final round of competition will consist of 60 minutes for oral pleadings. Applicant and Respondent are each allotted 30 minutes.
  - Each mooter shall speak for a minimum of 10 minutes.
  - There shall be maximum of 5 minutes allotted for rebuttal round.
5. Final Round Final round would be conducted on MS-Teams via virtual platform. The final round of competition shall consist of 60 minutes of oral pleadings. Applicant and Respondent are each allotted 30 minutes.
  - Each mooter shall speak for a minimum of 10 minutes.
  - There shall be maximum of 5 minutes allotted for rebuttal round.
6. Additional rules:
  - Any extension of time for presenting arguments beyond the specified period is subject to the discretion of the Adjudicating Panel.
  - No Team shall reserve more than 5 minutes for Rebuttals.
  - The winner of each court-room will be decided on the basis of the scores awarded by the judges in this round and the marks awarded by Memorial Evaluation Committee.
  - At the end of preliminary rounds, the top eight teams will qualify for the quarter finals on the basis of their wins.

- In case of a tie, the marks of the memorials will be considered in addition to the scores of preliminary rounds. The team with the higher score will advance to the Quarter Finals.
- The quarter final, Semifinal and the final rounds shall be knock-out rounds. A Team will be credited with a win in the quarter final, Semifinal and the final rounds, if their total marks, are higher than their opponent team.
- In case of a tie, the total oral marks of the Teams in the previous round(s) will be considered. The Team with the higher score will win.

## SCORING IN THE ORAL ROUNDS

The Oral Pleading Session would be marked on a scale of 100 per Panelist and would be evaluated on the following grounds-

## ONLINE PLATFORM RULES

1. The participants must ensure that they have a strong internet connection with good audio and video facilities. They must use laptops or PC for the oral rounds. The use of cell phones is prohibited.
2. The participants are required to have the video-conferencing software installed on their computers as the oral rounds would be held on that platform.
3. The participants (speakers) must ensure that any noise or audio other than the voice of the participant should not disturb the other participants during the online oral rounds. It is advisable to plan and prepare for the online oral rounds in advance accordingly.
4. All participants must join the session using their team code and speaker code. The teams must ensure that they do not disclose the identity of their college at any stage during the competitions. Any kind of canvassing shall lead to the disqualification of the teams.
5. The Organizing Committee's interpretation of the rules shall be final and binding.
6. The Organizing Committee has the full authorization to adopt any measures not outlined in the Virtual Rules in case of a contingency to facilitate the conduct of the rounds.
7. The Organizing Committee reserves the right take strict actions against any team on the spot, if in the opinion of the Judges, the team is acting in a manner so as to unfairly cause prejudice to the opposing team or indulging in any other inappropriate conduct that is averse to the idea of fair competition.
8. Some of these rules may be subject to amendment or addendums may be added so as to account for a situation previously not contemplated. The participants will be notified of these changes as and when they happen.

## MISCELLANEOUS

### 1. Reporting of Results

Cumulative Memorial Score of each team, Score-sheet of the Preliminary, Quarterfinal, Semi-final and Final Rounds will be notified to the teams after the competition.

### 2. Interpretation of Rules

The **MOOT COURT COMMITTEE** shall serve as final arbiter of implementation and interpretation of these Rules.

## 3. Awards

1. The Winning Team shall be awarded a cash prize of 20,000 along with E-Certificates and Certificate in Hard Copy
2. The Runner-ups Team shall be awarded a cash prize of 15,000/-INR along with E-Certificates and Certificate in Hard Copy.
3. The Best Speaker shall be awarded a cash prize of 2,500 INR along with E-Certificate and Certificate in Hard Copy.
4. The Best Written Submission (Memorial) shall be awarded a cash prize of 5,000/-INR along with E-Certificates and Certificate in Hard Copy.
5. The Best Researcher shall be awarded a cash prize of 2,500/-INR along with E-Certificate and Certificate in Hard Copy.
6. All the participants shall be awarded E-certificates

## 4. Complaint Procedure

1. If a Team believes that violation of the Competition Rules has taken place at any stage of the Competition, the Team(s) within half an hour after the completion of their round in which violation has allegedly occurred should register a complaint in writing to the organising committee. Team(s) under no circumstances shall approach the Panel with any complaints.
2. Teams may approach to Moot Court Committee for redressal of their complaint which shall be in writing. Complaint shall clearly describe the violation and the parties involved in the violation. The Team shall not directly approach the judges regarding a violation of these Rules.
3. Moot Court Committee will have a final say on the Complaints made by a Team.
