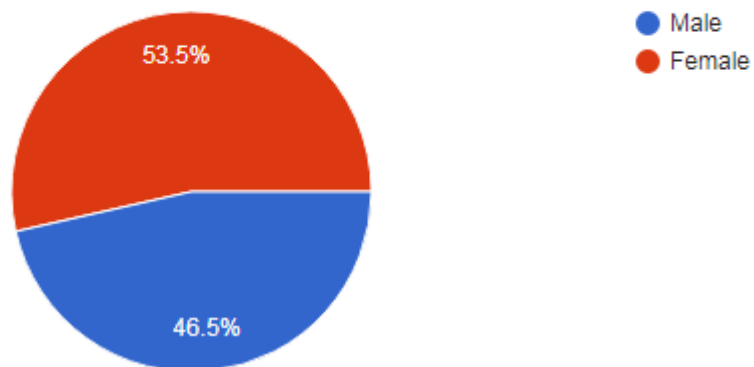

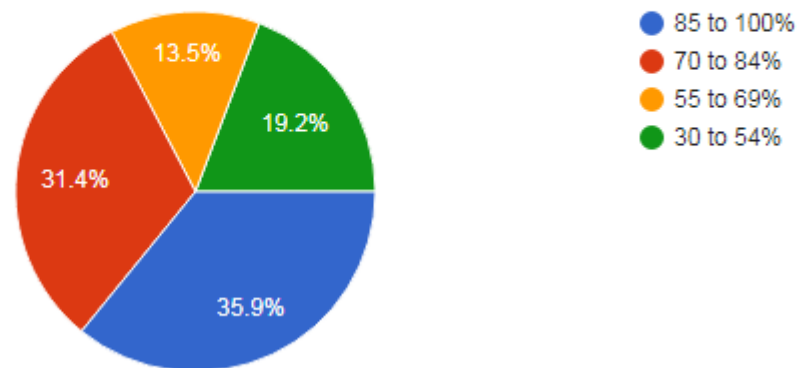
What degree program are you pursuing now? \*

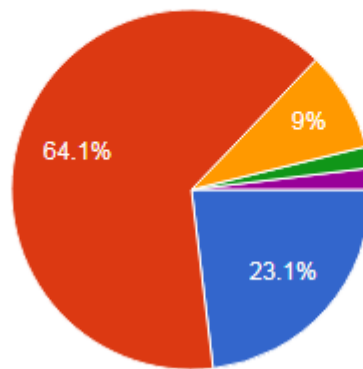

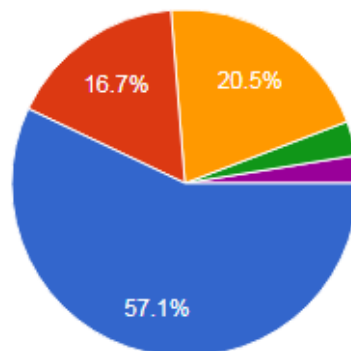

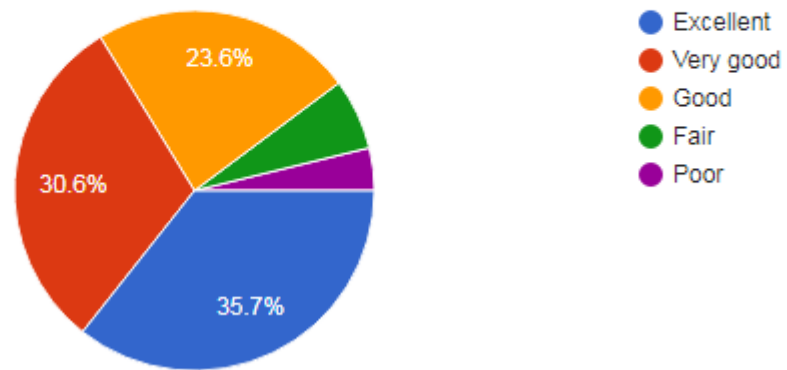

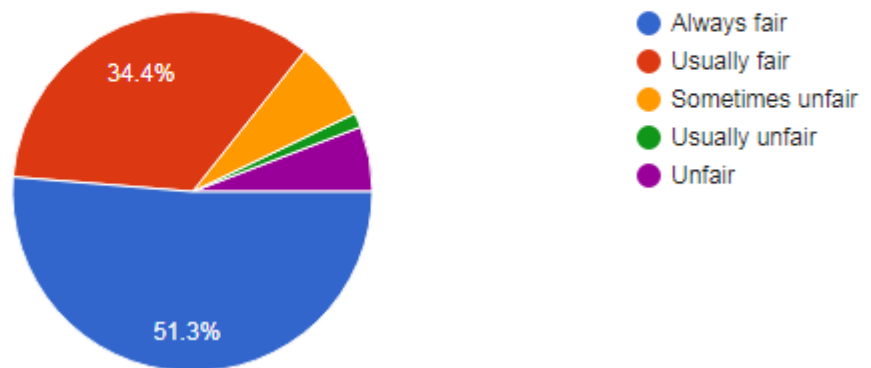
4) The teacher's approach to teaching can best be described as

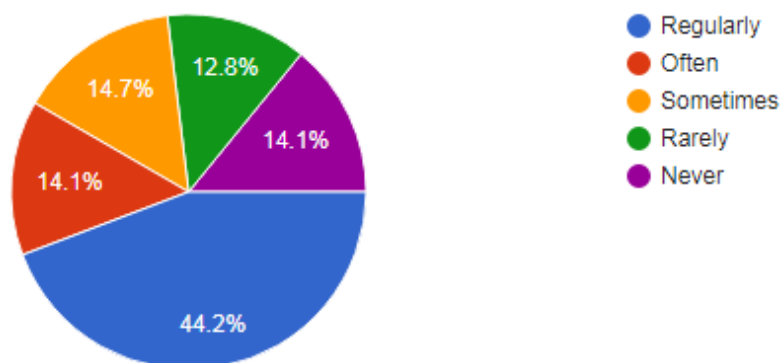

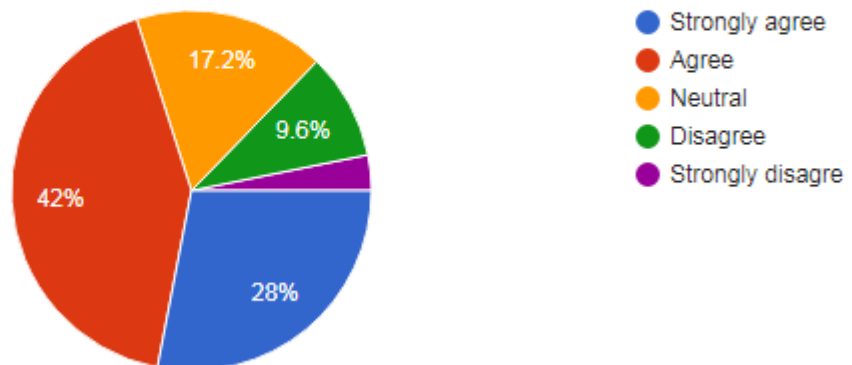

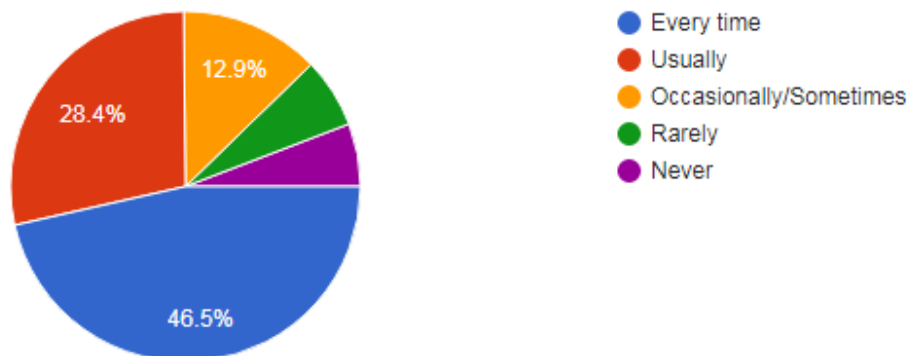

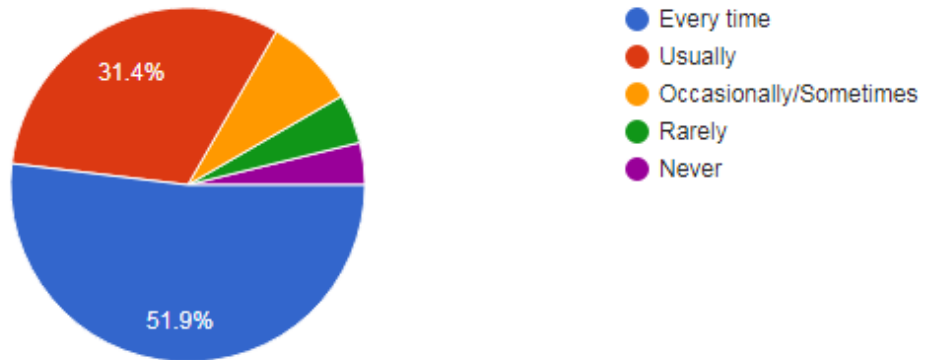

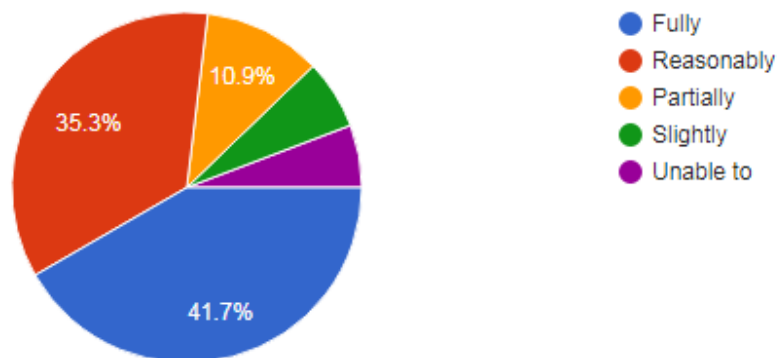

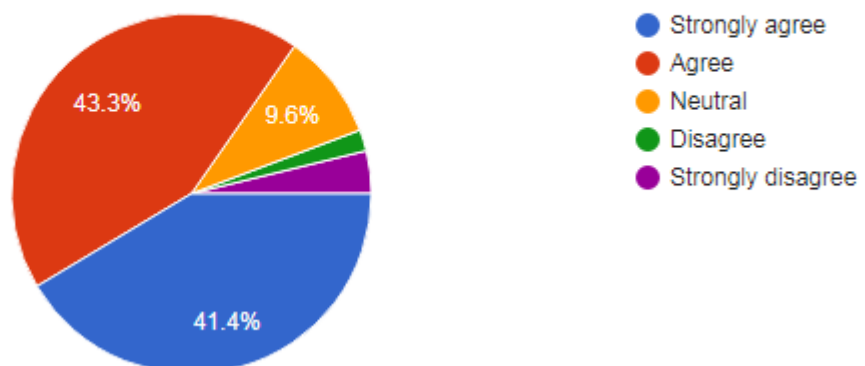

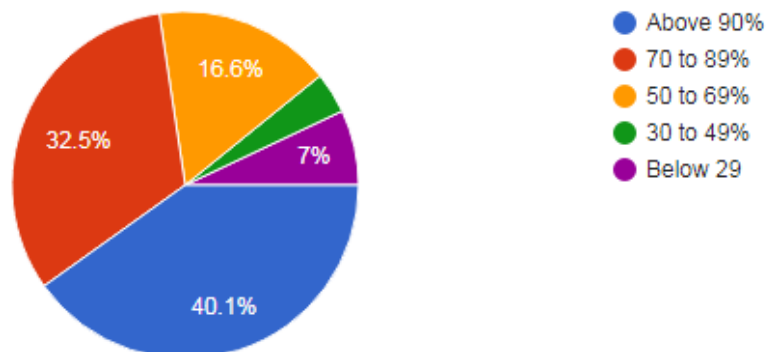
